

## WIN A NEW MG3 CAR COMPETITION RULES- AUGUST 2025

Read these competition rules carefully. These competition rules ("rules") explain your rights and duties under this competition. If you take part in this competition or accept any Prize, these rules will apply to you, and you agree that the person running the competition ("the Promoters) can assume that you have read and agreed to be legally bound these competition rules. Promoter(s) Name(s):	The Promoters of this competition are MG Finance, a product of WesBank, a division of FirstRand Bank Limited (MG Finance) with Reg. No. 1929/001225/06 and SAIC South Africa (Pty) Ltd with Reg No. (2024/028623/07) (MG Motor).  In these rules we refer to the above parties as the "Promoters". We refer to participants as "you".
What is the Prize?	The Prize of this competition is:  1. A new MG3 Motor Vehicle; and 2. An additional Prize to the value of R 10 000 (Ten Thousand Rand) will be awarded to the Winner, provided the Winner has posted the competition on any of their social media platforms and tagged MG Motor's official social media accounts using the hashtag #mymg3. MG Motor's social media platforms are limited to:  (a) Meta- mgmotorsouthafrica (b) X- mgmotorza (c) TikTok- @mg.south.africa (d) Instagram- mgmotors_za
	(the Prize).  The Promoters shall solely determine the conditions of the competition and the Promoters decision is final.
	Prize conditions:
	The competition is open to all persons who meet the qualifying criteria set out below.
	<ol> <li>The Prize must be collected by the Winner at an MG Motor Dealership closest to their place of residence. The Prize does not include the costs of travel in order to accept and take delivery of the Prize.</li> </ol>
	<ol> <li>The Prize does not include any servicing and maintenance of the vehicle, insurance, extended warranty or service plan, nor any additional enhancements to the vehicle after the Prize has been awarded.</li> </ol>

- The standard vehicle warranty and technical details will be explained to the Winner by a MG Motor South Africa representative.
   The Prize includes a full tank of fuel as well as the cost of registering and the first licencing of the Prize into the Winner's name. The Prize is not transferable to another party.
   The Winner must provide all necessary information and documentation required for the registration and licencing of the vehicle into the Winner's

# How to enter and who can take part?

You will automatically be entered into the competition to stand a chance to win the Prize when you visit any approved MG Motor Dealership, test drive a new MG3 Vehicle and submit a finance application with MG Finance.

Who cannot take part?	The following persons may not take part in this competition even if they qualify to take part. They will forfeit (give up) any Prizes awarded to them:
	a) Any employee of the promoter(s).
	b) Any director, member, partner, agent of, or consultant of the promoter(s).
	c) Any other person who is directly or indirectly controls the promoter(s).
	d) Any supplier of goods and services in connection with this competition.
	e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above.
	f) Any person whose accounts and credit agreements with WesBank, FNB or FirstRand Bank Limited are not in good standing. This means that none of your WesBank, FNB and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with WesBank, FNB or FirstRand Bank.
