



## WIN A NEW MG3 CAR COMPETITION RULES– AUGUST 2025

Read these competition rules carefully. These competition rules (“rules”) explain your rights and duties under this competition. If you take part in this competition or accept any Prize, these rules will apply to you, and you agree that the person running the competition (“the Promoters”) can assume that you have read and agreed to be legally bound these competition rules. <b>Promoter(s) Name(s):</b>	<p>The Promoters of this competition are MG Finance, a product of WesBank, a division of FirstRand Bank Limited (MG Finance) with Reg. No. 1929/001225/06 and SAIC South Africa (Pty) Ltd with Reg No. (2024/028623/07) (MG Motor).</p> <p>In these rules we refer to the above parties as the “Promoters”. We refer to participants as “you”.</p>
<b>What is the Prize?</b>	<p>The Prize of this competition is:</p> <ol style="list-style-type: none"> <li>1. A new MG3 Motor Vehicle; and</li> <li>2. An additional Prize to the value of R 10 000 (Ten Thousand Rand) will be awarded to the Winner, provided the Winner has posted the competition on any of their social media platforms and tagged MG Motor’s official social media accounts using the hashtag #mymg3. MG Motor’s social media platforms are limited to: <ol style="list-style-type: none"> <li>(a) Meta- mgmotorsouthafrica</li> <li>(b) X- mgmotorza</li> <li>(c) TikTok- @mg.south.africa</li> <li>(d) Instagram- mgmotors_za</li> </ol> </li> </ol> <p>(the Prize).</p> <p>The Promoters shall solely determine the conditions of the competition and the Promoters decision is final.</p> <p>Prize conditions:</p> <ol style="list-style-type: none"> <li>1. The competition is open to all persons who meet the qualifying criteria set out below.</li> <li>2. The Prize must be collected by the Winner at an MG Motor Dealership closest to their place of residence. The Prize does not include the costs of travel in order to accept and take delivery of the Prize.</li> <li>3. 	<ol style="list-style-type: none"> <li>4. The standard vehicle warranty and technical details will be explained to the Winner by a MG Motor South Africa representative.</li> <li>5. The Prize includes a full tank of fuel as well as the cost of registering and the first licencing of the Prize into the Winner's name. The Prize is not transferable to another party.</li> <li>6. The Winner must provide all necessary information and documentation required for the registration and licencing of the vehicle into the Winner's name, including but not limited to FICA documentation required for the finance application.</li> <li>7. Once the Prize is registered in the Winner's name, the Winner takes full responsibility for the Prize, including but not limited to insuring the Prize.</li> <li>8. Upon acceptance of the Prize by the Winner, all risk in and to the vehicle transfers to the Winner and the Promoters accept no liability for any loss, damage, theft, any requirements or additional costs associated with the Prize. The Winner indemnifies the Promoters of all risk and liability associated with the Prize.</li> <li>9. <b>Entries open and close:</b>	<p>Entries open on 01 August 2025 at 08h00.</p> <p>Entries close on 31 October 2025 at 17h00.</p> <p>The Promoters reserve the right to extend the competition. Notice of this will be posted in these rules.</p>
<b>How to enter and who can take part?</b>	<p>You will automatically be entered into the competition to stand a chance to win the Prize when you visit any approved MG Motor Dealership, test drive a new MG3 Vehicle and submit a finance application with MG Finance.</p>

<b>Who cannot take part?</b>	<p>The following persons may not take part in this competition even if they qualify to take part. They will forfeit (give up) any Prizes awarded to them:</p> <ul style="list-style-type: none"> <li>a) Any employee of the promoter(s).</li> <li>b) Any director, member, partner, agent of, or consultant of the promoter(s).</li> <li>c) Any other person who is directly or indirectly controls the promoter(s).</li> <li>d) Any supplier of goods and services in connection with this competition.</li> <li>e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above.</li> <li>f) Any person whose accounts and credit agreements with WesBank, FNB or FirstRand Bank Limited are not in good standing. <i>This means that none of your WesBank, FNB and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with WesBank, FNB or FirstRand Bank. Legal process means any legal proceedings in any court of law involving you and WesBank, FNB or FirstRand Bank, including but not limited to: collections, liquidation and sequestration proceedings. <b>How will Winner(s) be notified?</b>	<p>The Promoters will attempt to contact you via telephone within two weeks of the draw. If you cannot be reached after 3 (THREE) attempts, the Promoters reserve the right to draw a replacement Winner.</p> <p>The replacement Winner will be selected by way of a systematic random draw that will take place on 05 December 2025 and these rules shall apply to such replacement Winner, save that the deadline for claiming the Prize for any replacement Winner will be 30 days after the replacement Winner is contacted.</p> <p>The Winner will be required to provide their personal details and sign documentation required by law to effect the registration, licencing and hand-over of the Prize.</p>

<b>Disqualifications from entry</b>	<p>The Promoters reserve the right to disqualify any entrant suspected of fraud or cheating including without limitations, through the manipulation of code or otherwise frequently falsifying data.</p> <p>Participants who may pass away at any time during the competition period and up to the draw date will automatically be disqualified from the competition.</p>
